Introduction

Manu Taiko, Toro Parirau is a kaupae 4, 60 credit qualification intended for people new to governance who want to develop their skills and knowledge to fulfil kaupapa Māori based governance roles and activities for their whanau, hapū, iwi and hāpori. Graduates will be able to understand and apply concepts of kotahitanga, whanaungatanga, pono me te tika, kaitiakitanga and rangatiratanga in their governance roles and activities with supervision, support and guidance.

Evidence

The education organisations provided a range of evidence to demonstrate that their graduates met the graduate profile outcomes.

The criteria used to judge the evaluation question were:

- The nature, quality, integration of the guiding kaupapa and integrity of the evidence presented by the education organisation.
- How well the organisation has analysed, interpreted and validated the evidence, and used the understanding gained to achieve actual or improved consistency.
- The extent to which the education organisation can reasonably justify and validate claims and statements relating to the consistency of graduate outcomes, including in relation to other providers of programmes leading to the qualification

Final consistency review report

The evidence presented by the education organisation clearly demonstrates how its graduates have consistently met the intended outcomes of the qualification including:

- Evidence that the kaupapa are embedded into the four konae of the programme
- Clear evidence of assessment linked to developing understanding and practical application of kaupapa
- Graduate feedback that demonstrated an increase in their confidence to apply their understanding of the kaupapa before and after the programme.
- Stakeholder feedback affirming graduate understanding and demonstration of kaupapa.

The education organisation has demonstrated its capability in self-reflective practice (gathering, analysing and using data to create improvements) evidenced through its regular programme reviews informed by student, graduate and stakeholder feedback.

The quality of this information could be enhanced with formalised destination data and recent external moderation of assessments.

Overall, the self-reflection and evidence supplied by the organisation found sufficient makes a convincing case to demonstrate that the graduates match the graduate outcomes at the determined threshold.
