Outcome statement/Te tauāki ā-hua

<p>Strategic Purpose statement/Te rautaki o te tohu</p> <p>This qualification is intended for whānau, hapū, iwi and hapori with an interest or some theoretical knowledge and operational experience in Mahinga Kai (Māori Food Production) who are seeking a formal qualification to work toward cultural confidence with limited supervision at an introductory level.</p> <p>The purpose of the qualification is to validate and enhance learners' knowledge, understanding, and skills in Mahinga Kai, with a view to preserving, enhancing, and promoting this body of knowledge for current and future generations. Te iwi Māori and Aotearoa will benefit from having graduates who have, from a te ao Māori perspective, an appreciation for mātauranga Mahinga Kai, and are able to apply those skills and knowledge.</p> <p>Graduates will be able to work with whānau, hapū, iwi, and hapori demonstrating and applying mātauranga Mahinga Kai as a unique body of knowledge to enhance connection to Ao Māori.</p>

Guiding Principles/Ngā kaupapa o te tohu

Whanaungatanga

Whanaungatanga embraces those skills and strategies that relate to communications and relationships, associated with Mahinga Kai activities, such as being able to understand different types of relationships and stakeholders, and knowing how to establish, maintain and enhance relationships.

Te Pono me te Tika

Te Pono me te Tika encompasses important aspects of the protection and sustainability of Mahinga Kai resources that relate to kawa and tikanga; legal obligations and compliance issues, systems and procedures and ethics, and acting in a way that is socially and culturally responsible. It also investigates how these protocols can be utilised to achieve the best outcomes for whānau, hapū, iwi and hapori.

Kaitiakitanga

Kaitiakitanga refers to the skills and knowledge needed in the production of natural and physical resources relating to kai and the waiora benefits of engaging in Mahinga Kai activities. Graduates will be expected to understand how such taonga and resources can be protected and sustained in a way that aligns with tikanga, legislation and the aspirations of the whānau, hapū, iwi and hapori.

Tūrangawaewae

Tūrangawaewae affirms the mātauranga and mana held amongst the whānau, hapū, iwi adhering to the tikanga of mana whenua and honouring the environmental, cultural and spiritual significance and reconnects to the location, whakapapa, stories, and the kawa and tikanga practices associated with Mahinga Kai and the principle of aroha ki te tangata.

Rangatiratanga

Rangatiratanga describes the skills, processes, kawa and tikanga that are utilised for Mahinga Kai protection and sustainability. Including knowledge about unique Mahinga Kai mātauranga and the roles and responsibilities of mana whenua alongside the whānau, hapū, iwi and hapori.

Pūkengatanga

Pūkengatanga incorporates knowledge and skills required to effectively utilise traditional and modern technologies and tools to maintain and enhance the mātauranga Mahinga Kai systems of our tūpuna.

Education Pathway/Ngā huarahi mātauranga

This qualification may lead to further study at a higher level in environmental, horticulture, agriculture, aquaculture, viticulture, apiculture, and conservation studies.

Employment, Cultural, Community Pathway/Ko ngā huarahi ā-mahi, ā-ahurea, ā-whānau, ā-hapū, ā-iwi, ā-hapori anō hoki

Graduates of this certificate will have the skills and knowledge to contribute to future Mahinga Kai development of whānau, hapū, iwi, and hapori as horticulture and agriculture production assistants, nursery assistants, viticulture assistants, seafood processing work, introductory fishing/seafood harvesting crew positions, aquarist and apiculture assistant positions.

This qualification provides a pathway for graduates to develop capability and capacity to protect, maintain, and enrich mātauranga Mahinga Kai for whānau, hapū, iwi, and hapori for future and current generations.

Contribution to hapori and cultural roles may include involvement as the following:

- Working as part of a collective to maintain whānau, hapū and hapori māra kai.
- Kaimahi harvesting seafood, fishing, hunting, gathering traditional kai to fulfil the manaakitanga obligations and responsibilities to protect the mana and te tino rangatiratanga of the whānau, hapū, iwi and hapori.
