Outcome statement/Te tauāki ā-hua

Strategic Purpose statement/ Te rautaki o te tohu

This qualification is for people who wish to work with whānau in the development of a whānau-centred approach that supports whānau wellbeing.

The purpose of this qualification is to provide graduates with a range of knowledge, skills and experiences in mātauranga Māori wellbeing approaches.

Graduates of this qualification will be able to under limited supervision apply knowledge of Māori philosophies and theories of Māori wellbeing for a range of whānau ora contexts.

Graduate Profile/Ngā hua o te tohu

1. Develop and implement communication and relationship strategies to form a coordinated approach in the delivery of services to whānau, hapū, iwi and or hapori and relevant stakeholders as an expression of whanaungatanga.
2. Apply a range of standard and non-standard systems and processes to develop and implement whānau-centred services that support best outcomes for whānau as expressions of kaitiakitanga and te pono me te tika.
3. Work collaboratively and effectively with whānau to develop and implement a whānau ora plan as an expression of manaakitanga and pukengatanga.
4. Review and evaluate own practice and performance to self-manage own strengths and weaknesses as an expression of rangatiratanga.

Guiding Principles

Whanaungatanga – Highlights the importance of reo, tikanga and kawa in establishing, building and maintaining quality relationships within and between tangata Māori with disability and their whānau, hapū, iwi and hapori, health and/or social services and other key stakeholders.

Te Pono me te tika – Encompasses important aspects of Tikanga Māori and kawa; legal obligations and compliance issues, systems and procedures, processes and ethics, and acting in a way that is socially and culturally responsible. It also looks into how these tools can be utilised to achieve the best outcomes for whānau, hapū, iwi and hapori.

Kaitiakitanga – Refers to the skills and knowledge needed to support the protection, maintenance and strengthening of the mauri, mana and tapu of whānau through the delivery of culturally appropriate, effective and timely health and/or social services. It also looks into how these tools can be utilised to achieve the best outcomes for whānau, hapū, iwi and hapori.

Pukengatanga – Highlights the importance of keeping engaged and up to date with new knowledge and technologies and models of whānau-centred practices and services; the ability to self-reflect on one's own model of practice as part of continuous self-improvement; and sharing lessons learnt with other kaimahi, providers, whānau and other key stakeholders.

Manaakitanga – Signifies as fundamental the ability of whānau-centred kaimahi to work together with whānau in a caring and mana-enhancing way underpinned by te reo, tikanga and kawa, and where the focus is on strengths and abilities.

Rangatiratanga – Emphasises the importance of kaimahi having the knowledge, skills, and experience to lead the delivery of whānau-centred health and/or social services to whānau, including: knowledge of local kawa and tikanga; use of te reo; role-modelling positive behaviours based on kaupapa Māori principles; and meeting legal and ethical requirements in a professional manner.
